Information We Collect

We collect personal information only when you voluntarily submit it through our website forms, including:

- **Demo Request Forms:** Name, email address, company name, and job title/role

We do not collect financial information, payment details, or any sensitive personal data through our website.

How We Use Your Information

We use the information you provide to:

- Send product updates and relevant information about our M&A platform
- Conduct intermittent sales outreach and marketing communications related to our services

Data Storage and Security

Your information is stored securely in an encrypted database. We implement industry-standard security measures to protect your personal information from unauthorized access, disclosure, alteration, or destruction.

Data Sharing and Disclosure

We do not sell, rent, or share your personal information with third parties for their marketing purposes. We may share your information only in the following limited circumstances:

- **Legal Requirements:** When required by law, regulation, legal process, or governmental request
- **Business Transfers:** In connection with a merger, acquisition, or sale of assets, where your information would be transferred as part of that transaction

Your Rights and Choices

All Users

- **Correction:** Request correction of inaccurate information

We maintain contact information indefinitely for legitimate business purposes (sales, marketing, and customer relationship management) unless you request its removal.
